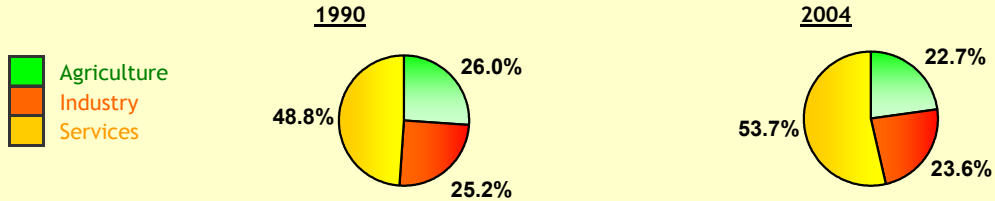

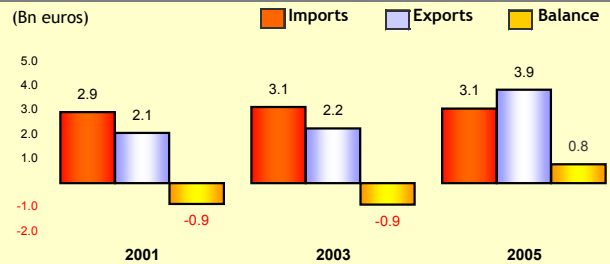
## PAKISTAN MERCHANDISE TRADE WITH THE WORLD

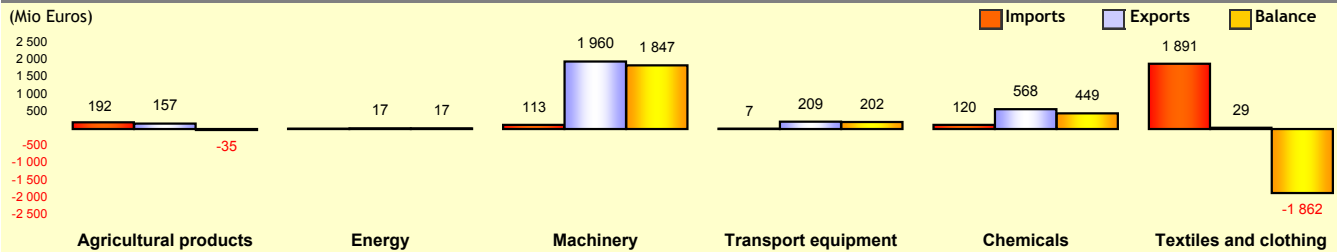

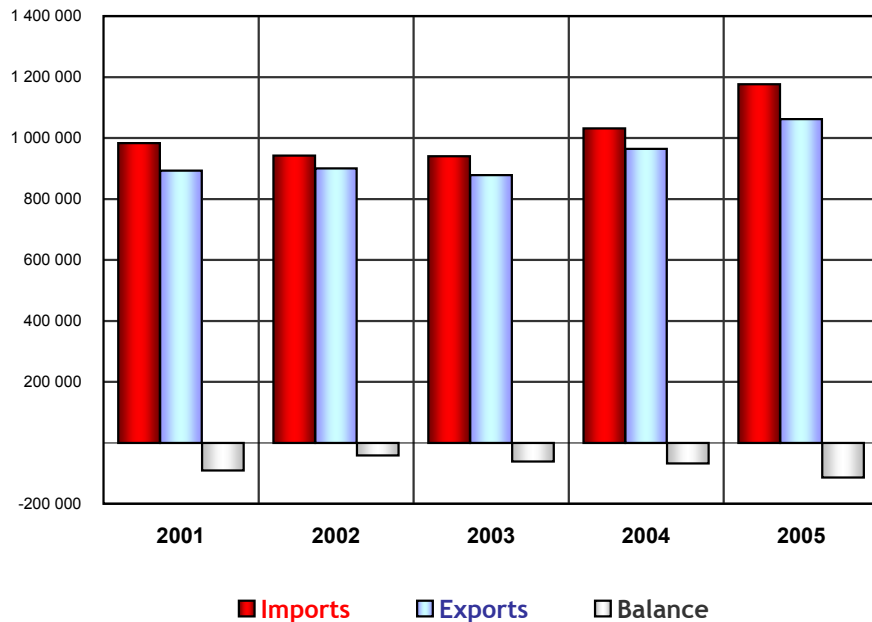

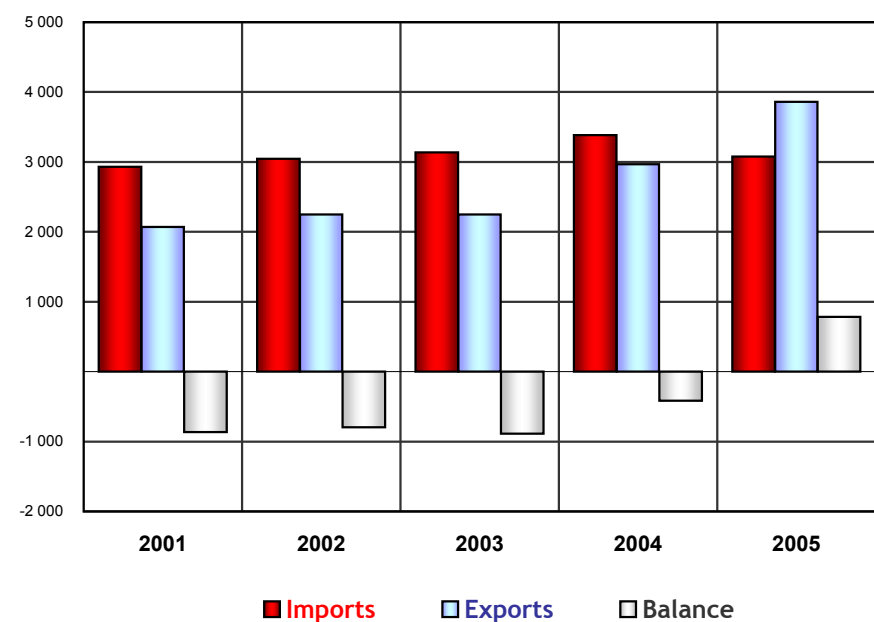

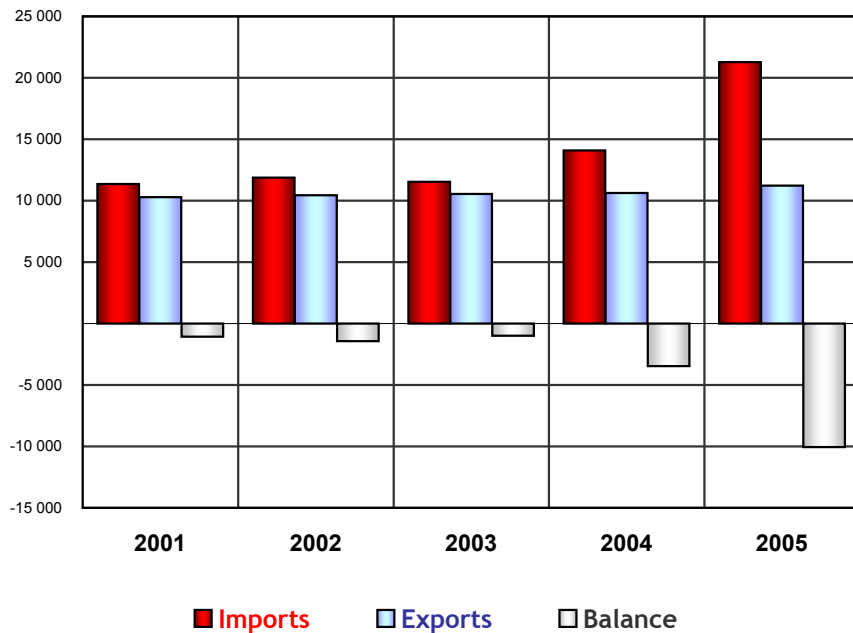

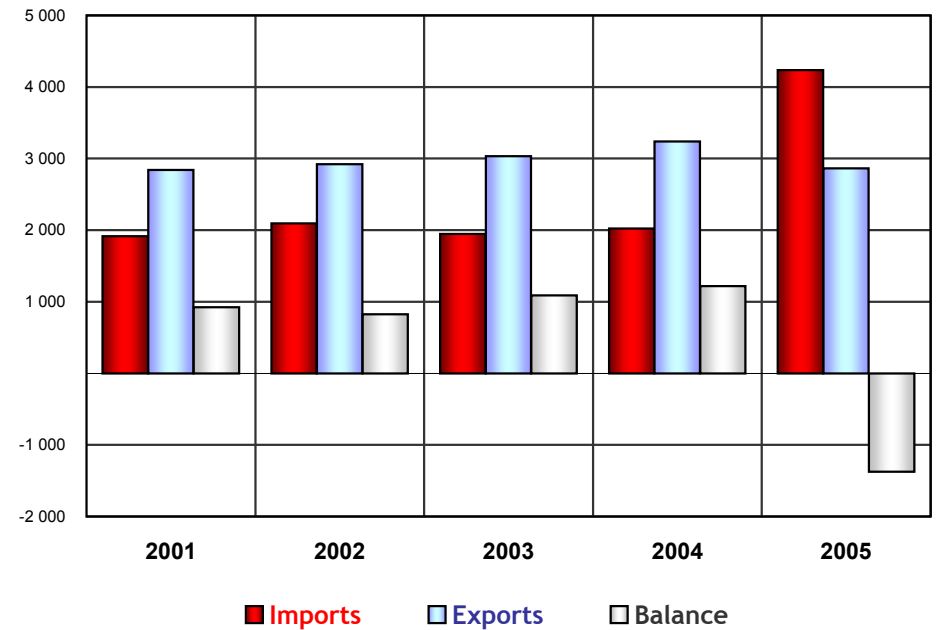

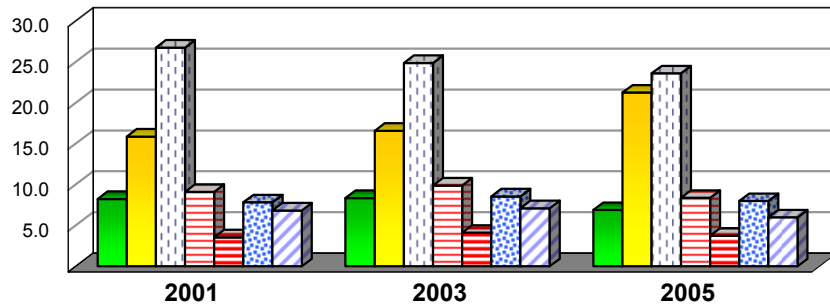

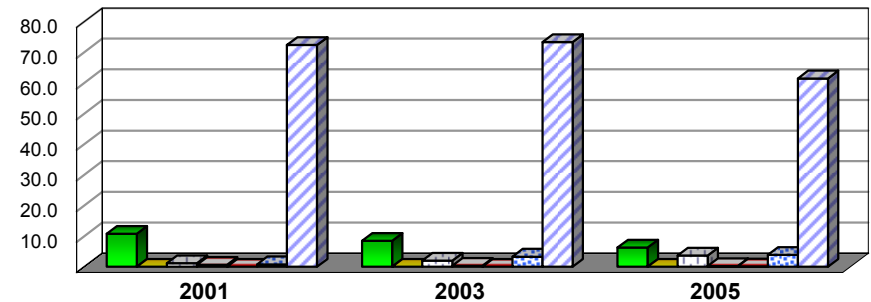

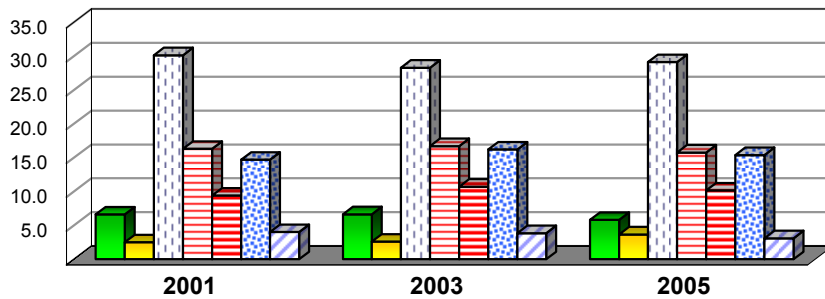

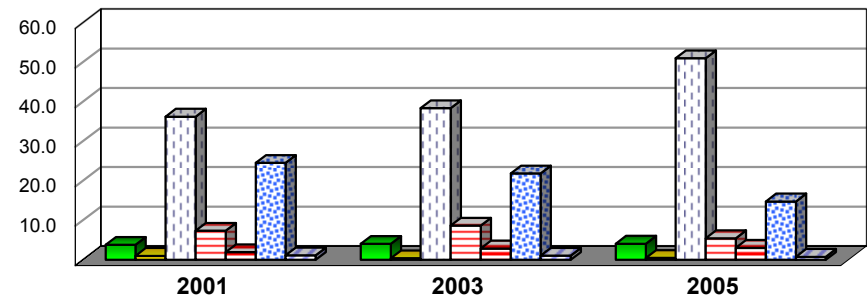

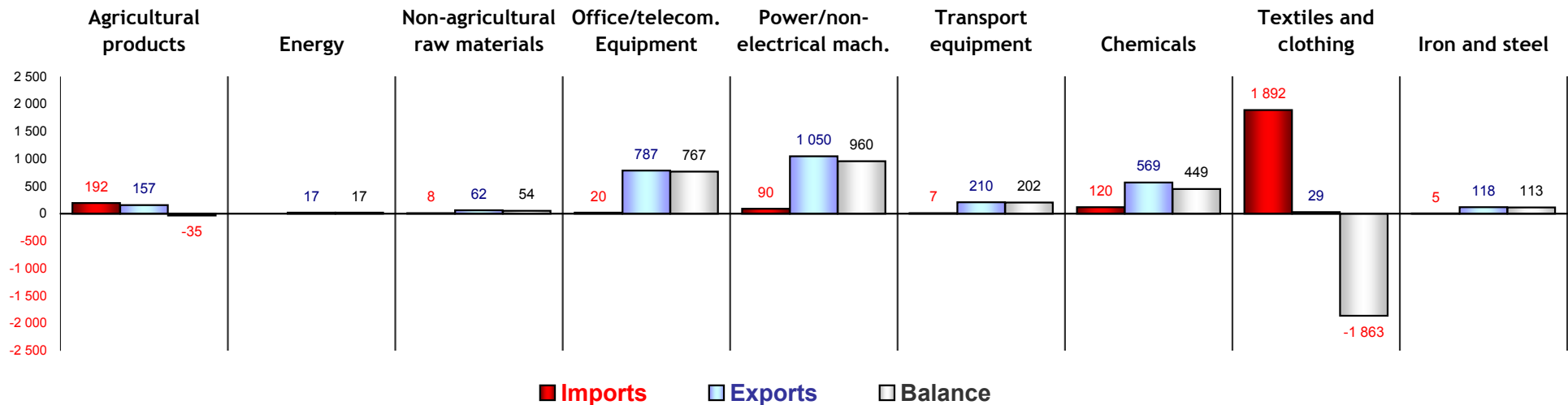
